Some teachers cover up the spaces with fabric or other created coverings of their own. Only one general classroom in the building has a sink, and it is similar to those more frequently found in wet bars than in industrial spaces or classrooms. The first grades do not have sinks or restrooms in their spaces.

The older parts of the building have low ceilings, narrow hallways, and almost no natural light in those areas. Ceiling tiles are old and there are many leaks with buckets placed to catch the water. Some spaces are missing ceiling tiles due to water leaks. One of the old hallways only has classrooms on one side, and the other side of the hall has a solid wall.
Exterior Environment	0.877	1.350	Fair	There are a couple of open spaces, one in the front and one in the back of the school, that could be transformed into outdoor learning labs or social gathering spaces.
