Environment	1.755	3.510	Poor	The classrooms on the front of the building have interior HVAC systems which are extremely noisy. The HVAC system throughout the general classrooms is not consistent. The walls are concrete block and ceramic tile giving the classrooms a sterile appearance.

Location	1.711	2.632	Fair	The school is configured with two separate buildings on different levels. Students with mobility problems cannot access the various levels due to stairs. One stairway does have a wheelchair lift mechanism.
Storage/Fixed Equip	1.316	2.632	Poor	The general classrooms have one lockable wardrobe cabinet. They do not have additional storage cabinets and bookshelves. Electrical outlets are not adequate and require the use of numerous extension cords.
